Binbrook Church of England Primary School uses closed circuit television (CCTV) images for the prevention, identification and reduction of crime and to monitor the school buildings in order to provide a safe and secure environment for pupils, staff and visitors, and to prevent the loss or damage to school property.

CCTV surveillance at the School is intended for the purpose of:

- Protecting the school buildings and school assets both during and after school hours;
- Promoting the health and safety of staff, pupils and visitors;
- Reducing the incidence of crime and anti-social behaviour (including theft and vandalism);
- Supporting the Police in a bid to deter and detect crime;
- Assisting in identifying, apprehending and prosecuting offenders; and
- Ensuring that the school rules are respected so that the school can be properly managed.

The system comprises of 10 cameras around the school site including the Children's Centre.

The CCTV is owned and operated by the school and the deployment of which is determined by the school's Headteacher. The CCTV is a standalone system and is operated by the school.

The CCTV is monitored centrally from the headteacher's office by the Headteacher and School Business Manager.

The school is registered with the Information Commissioner's Office (ICO)

All authorised operators with access to recorded images are aware of the procedures that need to be followed when accessing the images. All employees are aware of the restrictions in relation to access to and disclosure of recorded images.

The school complies with the ICO CCTV Code of Practice to ensure that it is used responsibly and safeguards both trust and confidence in its continued use.

The use of the CCTV system will be conducted in a professional, ethical and legal manner and any diversion of the use of CCTV security technologies for

other purposes is prohibited by this policy eg CCTV will not be used for monitoring employee performance.

CCTV monitoring of restricted access areas for security purposes will be conducted in a manner consistent with all existing policies adopted by the school, include Codes of Practice for dealing with complaints of Bullying & Harassment and other relevant policies, including the provisions set down in equality and other educational and related legislations.

Justification for Use of CCTV

The use of CCTV for safety and security purposes has been deemed to be justified by the Headteacher and Governing Body. The system is intended to capture video footage of intruders or of individuals damaging property or removing goods without authorisation or of anti-social behaviour.

CCTV systems will not be used to monitor normal teacher/student classroom activity in school. There is no CCTV installed within the school premises; all are external.

Location of Cameras

Cameras are sited so they only capture images relevant to the purposes for which they are installed and care will be taken to ensure that reasonable privacy expectations are not violated.

The school will ensure that the location of equipment is carefully considered to ensure that images captured comply with the Data Protection Act. The school will make every effort to position cameras so that their coverage is restricted to the school premises, including external areas of the school site.

CCTV is not used indoors.

Use of CCTV to monitor areas where individuals would have a reasonable expectation of privacy would be difficult to justify. No CCTV cameras are installed in any such area.

Cameras are placed so as to record external areas are positioned in such a way as to prevent or minimise recording of passers-by or of another person's private property.

CCTV Video Monitoring and recording of public access areas may take place for the following purposes:

- Protection of school buildings and property: the building's perimeter, entrances and exits, office locations, receiving areas for goods services;
- Monitoring of access control systems: monitor and record restricted access areas at entrances to buildings and other areas;
- Verification of security alarms: intruder alarms, exit door controls, external alarms;
- Video patrol of public areas: parking areas, main entrances/exit gates
- Criminal investigations (carried out by the police): robbery, burglary and theft surveillance.

Covert Surveillance

Binbrook Church of England Primary School will not engage in covert surveillance.

Notification

A copy of this CCTV Policy will be provided on request to staff, students, parents and visitors to the school and will be made available on the school website.

Adequate signage is displayed at the entrance of the school property.

Storage and Retention

The images captured by the CCTV system will be retained for a maximum of 35 days, except where the image identifies an issue and is retained specifically in the context of an investigation/prosecution of that issue.

The images/recordings will be stored in a secure environment.

Access will be restricted to authorised personnel. Supervising the access and maintenance of the CCTV system is the responsibility of the Headteacher.

In certain circumstances the recordings may also be viewed by other individuals in order to achieve the objectives set out above. When CCTV images are being viewed, access will be limited to authorised individuals on a need to know basis.

Access

Recorded footage and the monitoring equipment will be securely stored in a restricted area. Unauthorised access to that area will not be permitted at any time.

Access to the CCTV system and stored images will be restricted to authorised personnel only.

A record of the date of any disclosure request along with details of who the information has been provided to (the name of the person and organisation they represent), why they required it and how the request was dealt with will be kept in case of challenge.

Data will be provided to those requests authorised in a permanent format where possible. If this is not possible the data subject will be offered the opportunity to review the footage.

In relevant circumstances, CCTV footage may be accessed:

- By the Police where Binbrook C of E Primary School are required by law to make a report regarding the commission of a suspected crime; or
- Following a request by the police when a crime or suspected crime has taken place and/or when it is suspected that illegal/anti-social behaviour is taking place on the school's property; or
- To the HSE and/or any other statutory body charged with child safeguarding; or
- To assist the Headteacher in establishing facts in cases of unacceptable student behaviour in which case, the parents/guardians will be informed; or
- To data subjects (or their legal representatives), pursuant to a Subject Access Request; or
- To individuals (or their legal representatives) subject to a court order; or
- To the school insurance company where the insurance company requires same in order to pursue a claim for damage done to the insured property.

Subject Access Requests (SAR)

Individuals have the right to request access to CCTV footage relating to themselves under the Data Protection Act.

Individuals submitting requests for access will be asked to provide sufficient information to enable the footage relating to them to be identified. For example, date, time and location.

The school will respond to requests within 30 calendar days of receiving the request in line with the school's data protection policy.

The school reserves the right to refuse access to CCTV footage where this would prejudice the legal rights of other individuals or jeopardise an on-going investigation.

A record of the date of the disclosure along with the details of who the information has been provided to (the name of the person and the organisation they represent) and why they required it will be made.

In giving a person a copy of their data, the school provide a still/series of still pictures or a disk with relevant images. However, other images of other individuals will be obscured before the data is released.

Where footage contains images relating to 3rd parties, the school will take appropriate steps to mask and protect the identities of those individuals.

Complaints

Complaints and enquiries about the operation of CCTV within the school should be directed to the Headteacher in the first instance. Contact can be made via the school office.

Staff Training

Staff authorised to access the CCTV system will be trained to comply with this policy. Staff will understand that all information relating to CCTV images must be handled securely.

Staff will receive appropriate training to enable them to identify and handle different requests according to regulations.

Staff misuse of surveillance system information will lead to disciplinary proceedings.

Responsibilities

The Headteacher (or nominated deputy) will:

- Ensure that the use of CCTV systems is implemented in accordance with the policy set down the Binbrook C of E Primary School.
- Oversee and co-ordinate the use of CCTV monitoring for safety and security purposes within school.
- Ensure that all existing CCTV monitoring systems will be evaluated for compliance with this policy.
- Ensure that the CCTV monitoring at school is consistent with the highest standards and protections.
- Review camera locations and be responsible for the release of any information or recorded CCTV materials stored in compliance with this policy.
- Maintain a record of access (eg an access log) to the release of any material recorded or stored in the system.
- Ensure that monitoring records are not duplicated for release.
- Ensure that the perimeter of view from fixed location cameras conforms to this policy both internally and externally.
- Give consideration to both students and staff feedback/complaints regarding possible invasion of privacy or confidentiality due to the location of a particular CCTV camera or associated equipment.
- Ensure that all areas being monitored are not in breach of an enhanced expectation of the privacy of individuals within the school and be mindful that no such infringement is likely to take place.
- Ensure that external cameras are non-intrusive in terms of their positions and views of neighbouring residential housing and comply with the principle of "Reasonable Expectation of Privacy".
- Ensure that monitoring footage is stored in a secure place with access by authorised personnel only.
- Ensure that recordings are stored for a period not longer than 35 days and are then erased unless required as part of a criminal investigation or court proceedings (criminal or civil).
- Ensure that the camera control is solely to monitor suspicious behaviour, criminal damage etc and not to monitor individual characteristics.
- Ensure that the camera control is not infringing on an individual's reasonable expectation of privacy in public areas.
